What is the “**Personal Assessment Life Management Program**”

- ◆ **PALM Pre Trial** is a two-week intense life skills program, for individuals in the pre-trial stages of a judicial process.
 - ◆ **PALM Reentry** is also a **32 hour** life management program for individuals, returning home after an absence. PALM provides tools to help in correct decision making for successful reentry to society after the completion of a court-ordered term of incarceration or a treatment in lieu of incarceration.
- ◆ We intake clients from: Pre-trial Services –Probation / Parole/ Federal/ State/ County/ Courts. Juvenile Classes Court Referrals, Foster Care Services, School Counselors, Faith Organizations, Department of Family and Children Services, Probation and Parole, Juvenile Court Judges, and caregivers in absence of parents.
